

**WEST TISBURY PARKS & RECREATION
BEACH STICKER & PASS POLICY 2009**

1. Any person seeking access to Lambert's Cove Beach from mid-June through Labor Day must purchase and display a valid beach sticker or pass to the Parking Lot Attendant at the Lambert's Cove Beach lot. Stickers and passes will be sold at the Parks and Recreation shed at the west Tisbury School tennis courts. Stickers will be sold daily from 9a.m.- 12p.m. The cost for a car sticker is \$50. Walk-on Passes are \$10.

3. **ONLY ONE STICKER PER HOUSEHOLD** may be purchased for any given time period. Beach stickers are **NOT TRANSFERABLE**. If a house is rented to various parties during the summer, each party must purchase its own beach sticker or pass, and the owner's sticker is not valid during these rental periods. Car stickers must adhere to the driver's side window of the vehicle. **STICKERS ARE NOT TRANSFERABLE FROM ONE VEHICLE TO ANOTHER. ANY TAMPERING WITH OR ALTERING OF THE BEACH STICKER OR PASSES WILL RESULT IN THE REVOCATION OF BEACH PRIVILEGES.**

4. One Walk-on Pass per household may be purchased. This pass allows beach access to those arriving by bus, bicycle or on foot, and is good for adult and their children. Evidence of West Tisbury residence or a rental lease may be requested at the gate. This pass does not allow parking on the lot or on the road. Violators will be ticketed by the West Tisbury Police. Mopeds and motorcycles may use a Walk-on Pass but must park outside of the lot. If beachgoers from the same residence are arriving at different times, the first party must bring the Walk-on Pass and leave the name of the second party with the attendant..

5. Proof of residence or a signed lease for rental of a property in town is required at the time of purchase. A lease must show the rental dates, owner's name, and map and lot number of the property. When purchasing a car sticker, please have the license number of the vehicle.

6. Stickers or passes may be purchased by Inns and Guest Houses in West Tisbury at the commercial rate (\$75) for the number of rooms in the establishment. New Inns and Guest Houses must apply to the Parks & Recreation Committee for commercial status.

8. Replacement stickers are available as needed due to change of vehicles. The old sticker must be returned to the sticker seller and a new sticker will be issued at no charge.

9. Anyone wishing special consideration for a beach sticker or pass must submit a request in writing to the Parks & Recreation Committee, P.O.Box 278, West Tisbury, MA 02575.

10. West Tisbury residents and their renters should apply to the Trustees of Reservations at the Long Point gatehouse for a special sticker rate. For more information call the gatehouse at 693-7392.
