Fuel Oil Tank – Keene’s: John Keene said he wanted to install a 3,000 gallon fuel tank on the property on Old Stage Rd. Currently they have a 1,000 gallon tank that gets filled about 3 times a week. This will allow them to have capacity should the boats not run during a hurricane for example. This will comply with all DEP regulations. They will hire the same company to install that installed the Up-Island gas station tank. Manny said he wanted to see a roof over the tank and have it inspected annually by the company that installs the tank.

R. Knabel motioned to approve the installation of a 3,000 gallon fuel storage tank on the Keene’s property on Old Stage Road with the conditions that the tank have a roof over it and it is inspected annually and that it meet all state and local guidelines . D. Powers seconded the motion. The vote on the motioned was unanimous in favor.
