The Board reviewed the fiscal year 2019 warrant article for valuation updates. Within the last five years \$122,400 in warrant article monies has been used to support the services necessary from fiscal year 2014 through 2018. An average used yearly was \$24,480. In fiscal year 2018 the Board did NOT request warrant article monies. The Board voted the fiscal year 2019 warrant article in the amount of \$24,000. Unanimous.

The Board also reviewed Massachusetts General Law Chapter 59 Section 21A, "Additional compensation of assessors for courses of study". Although current staff and elected officials do not hold the CMA accreditation from the MAAO, Michael would like to request a warrant article accepting this section of the law to allow any member, staff or elected, in the future, who acquire this accreditation will be compensated a yearly stipend in the amount of \$1,000. After a short discussion the Board voted to submit a warrant article for fiscal year 2019 for Ch59, Sec21A. Unanimous.
