George Souratti, engineer, attended the meeting to explain the DWA application for Nooni & Shira Hammarlund. The application consisted of a request for the proposed leaching field to be constructed on a neighboring property which is owned by a family member who, as it was reported, gave permission for an easement. Health Agent Johnson reached out to Brian Dudley at the State's Southeast regional DEP office for assistance in determining whether the easement is legal and is awaiting a reply. The Board approved a Title 5 inspection report for Martisauskas (Brown Estate) after a review of the water report. The water tested within acceptable parameters with the exception of the PH which was 1/10 below the range of what is recommended. Health Agent Johnson gave official notice to the Board that FinCom gave approval for the budget and for the addition of a new P/T administrative assistant. Health Agent Johnson shared with the Board a complaint letter forwarded to his attention concerning 28 James Way. The letter sent in by a neighbor in the area complained about a deterioration situation in the neighborhood. The letter made specific reference to traffic concerns, noise, and the possibility that the large number of occupants living in the home may be in violation of State code and/or regulations. Health Agent discussed possible ways to address the situation and agreed to mailing the owner a letter notifying her of the concerns and to request a site visit. Health Agent also informed the Board that he was preparing to address concerns surrounding manure piles at Black Water farm. Health Agent Johnson explained that it was his understanding that other concerned individuals would be addressing the problem as well, and that Health Agent Johnson would seek to coordinate efforts.
