PRESENT: Tim Barnett, Erik Lowe, Hans van Nes, Omar Johnson and Susan Block

INVITED AND IN ATTENDANCE:

Mr. Hans van Nes inquired as to why he was not being allowed to cook sausage at the 2018 Winter's Farmers Market, as he had previously applied via a temporary food application to sell frozen meats and to cook sausage. The Board explained to Hans that they were not comfortable with the idea of his selling frozen meats and cooking meat (sausage) the same location where he also be selling frozen meats due to the potential for cross contamination. Mr. Van Nes was reminded that he had not followed procedure by bypassing the Farmers market coordinators who as a matter of procedure, approves applications before the Board makes determinations. Mr. Van Nes was informed that when the request was brought to the attention of the Farmer market coordinators it was rejected. Mr. van Nes was also told that the Fire Chief would need to approve of any cooking that took place in the open area of the Ag hall and that open flames would probably not be allowed. Mr. Van Nes main question and concern was in regards to why another vendor (Kitchen Porch) was allowed to pre-cook sausage and warm those sausages on a grill plate for direct sale, and his application to cook sausage was rejected? The Board explained that they were actually more comfortable with allowing Kitchen Porch engage in such activity, them being established food preparation operation working out of a licensed commercial kitchen, with a sound understanding of food safety. An attempt was made to review Kitchen Porch's application for the purpose of explaining why the Board approved their application but Health Agent Johnson did not have the Kitchen Porch application at his disposal at that time to review it. Hans was told that Kitchen Porch's application simply listed "sausage", with no indication that it was being cooked, but it was acknowledged that Kitchen Porch had served both frozen meat and cooked food for past events, and they (BOH), despite it being unclear on the application, were OK with Kitchen Porch serving the cooked sausage because their overall food experience and having met requirements. Hans has requested to see kitchen Porch's application and would like to further discuss the rejection of the cooking portion of his application. This particular matter will be revisited at Han's request once the Kitchen Porch application is made available for further review and discussion.
