OLD/NEW BUSINESS: The Board was provided with an update on Eversource in regards to efforts to halt spraying of herbicides here on the Vineyard, these efforts would be in line with similar and recent efforts on the Cape. The Board was reminded that even though West Tisbury is not in line for spraying, it is important that all the towns are unified on this issue. The Board was informed that a Barnstable County representative recently visited West Tisbury as scheduled and completed scanning information on properties that have Innovative Enhanced(I/A) systems. West Tisbury had previously adopted a bylaw allowing Barnstable County to monitor these I/A systems (compliance) under a grant that will be of great assistance to the Health Agent and the Town. The Board was informed of efforts to investigate a possible housing and nuisance complaint for a residence on Dolphine Merry Road. Previous efforts to contact the owner of the residence had been unsuccessful until now, hopefully more accurate contact information was recently obtained. The Board was provided an update on the Tisbury Great Pond meeting. Board members are aware that this first meeting brought together the stakeholders who will assist in efforts to more closely monitor the conditions of The Great Pond. Particular concerns revolve around more consistent and extensive testing. The Board was also informed of a request by Wes Pekor of the WT elementary school to allow the addition of a donated washer and dryer to be installed at the school. Mr. Pekor reports that he currently does the washing and drying outside of the school, and that it is a huge inconvenience. Health Agent Johnson has spoken with the Building Inspector about the request, and has informed Mr. Pekor that he needs to have a building contractor submit a plan and obtain any applicable permits.
