TRAILER PERMITS:

OLD/NEW BUSINESS: The WT BOH approved a letter of support for the TRI Community Development Block Grant which provides qualifying residents with assistance for home repairs. The Board also Ok'd the installation of a new water fountain (Bubbler) at the West Tisbury Elementary school. Health agent Johnson explained that he had spoken with the plumber and addressed concerns regarding contamination during the installation process. The Board acknowledged the completion of Health Agent Johnson's 6 month probationary period and signed off on a letter to personnel confirming their approval.

PERMITS: Board members signed off on Food Establishment Permits for Fella's and MJV Agricultural Society. Disposal Works Installers Permits were also approved by the Board with certain stipulations. Those stipulations requires that the Board allows installation on a case by case basis until this particular business has demonstrated to the Board's satisfaction, a consistent, acceptable quality of work.
