OLD/NEW BUSINESS: The Board was informed that Mass DEP will hold a public meeting on January 23rd, 2018 at the West Tisbury Public Library to discuss and respond to any public comments on their Tisbury Great Pond and Black Point Pond Estuarine system Draft Total Maximum Daily Load (TMDL) report for total nitrogen. Health Agent Johnson also received approval for a revision that was made to his recent budget submission. The revision consists of a request for a part-time Administrative Clerk. The Board approved a request for Health Agent to attend a Certified Pool Operator (CPO) training in the spring of 2018 in order to inspect pools at the standards. The Board was briefed on a letter from the Protect Our Cape Cod Aquifer (POCCA) outlining current efforts that are being made to prevent the spraying of herbicides on Cape Cod and Martha's Vineyard. Health Agent Johnson emphasized that even though West Tisbury is not currently in one of the areas scheduled for the sprayings, it is important for West Tisbury to be unified in any

Island-wide efforts; the Board expressed that they are in complete agreement that West Tisbury should support island-wide efforts.. Health Agent Johnson shared a letter, a CDC Health Advisory in regards to seasonal influenza A (H3N2). The letter provided basic information in the form of a summary, background and recommendations.
