- School reno, by far. RDH Report must be posted on EC page. Recommends approaching project in phases – e.g., Middle School – to make more palatable for funding; Reno of Middle School in and of itself may lead to needed 20% reduction.

Kate Warner:

- School determine current use based on MEI data; get plan on FY 2025; use loss of Green Communities as focal point. Largest issue will be staging.
- Level 3 charger at PSB further research needed for presentation to FinComm
- draw up specific plan for reaching 2040 goals to put before FinComm, all Town buildings Sue Hruby:
 - Essential to circle back to CLEAR report and highlight to residents urgent need that Town buildings be emergency-ready
