The following conditions are only applicable to Approved projects.

- 1. Failure to comply with all conditions stated herein, and with all related statutes and other regulatory measures, shall be deemed cause to revoke or modify this Order.
- amount here. 2. The Order does not grant any property rights or any exclusive privileges; it does not authorize any injury to private property or invasion of private rights.
 - This Order does not relieve the permittee or any other person of the necessity of complying with all other applicable federal, state, or local statutes, ordinances, bylaws, or regulations.
 - 4. The work authorized hereunder shall be completed within three years from the date of this Order unless either of the following apply:
 - a. The work is a maintenance dredging project as provided for in the Act; or
 - b. The time for completion has been extended to a specified date more than three years, but less than five years, from the date of issuance. If this Order is intended to be valid for more than three years, the extension date and the special circumstances warranting the extended time period are set forth as a special condition in this Order.
 - c. If the work is for a Test Project, this Order of Conditions shall be valid for no more than one year.
 - 5. This Order may be extended by the issuing authority for one or more periods of up to three years each upon application to the issuing authority at least 30 days prior to the expiration date of the Order. An Order of Conditions for a Test Project may be extended for one additional year only upon written application by the applicant, subject to the provisions of 310 CMR 10.05(11)(f).
 - 6. If this Order constitutes an Amended Order of Conditions, this Amended Order of Conditions does not extend the issuance date of the original Final Order of Conditions and the Order will expire on _____ unless extended in writing by the Department.
 - 7. Any fill used in connection with this project shall be clean fill. Any fill shall contain no trash, refuse, rubbish, or debris, including but not limited to lumber, bricks, plaster, wire, lath, paper, cardboard, pipe, tires, ashes, refrigerators, motor vehicles, or parts of any of the foregoing.

C. General Conditions Under Massachusetts Wetlands Protection Act

- 8. This Order is not final until all administrative appeal periods from this Order have elapsed, or if such an appeal has been taken, until all proceedings before the Department have been completed.
- 9. No work shall be undertaken until the Order has become final and then has been recorded in the Registry of Deeds or the Land Court for the district in which the land is located, within the chain of title of the affected property. In the case of recorded land, the Final Order shall also be noted in the Registry's Grantor Index under the name of the owner of the land upon which the proposed work is to be done. In the case of the registered land, the Final Order shall also be noted on the Land Court Certificate of Title of the owner of the land upon which the proposed work is done. The recording information shall be submitted to the Conservation Commission on the form at the end of this Order, which form must be stamped by the Registry of Deeds, prior to the commencement of work.
- 10. A sign shall be displayed at the site not less then two square feet or more than three square feet in size bearing the words,

- 11. Where the Department of Environmental Protection is requested to issue a Superseding Order, the Conservation Commission shall be a party to all agency proceedings and hearings before MassDEP.
- 12. Upon completion of the work described herein, the applicant shall submit a Request for Certificate of Compliance (WPA Form 8A) to the Conservation Commission.
- The work shall conform to the plans and special conditions referenced in this order.
- 14. Any change to the plans identified in Condition #13 above shall require the applicant to inquire of the Conservation Commission in writing whether the change is significant enough to require the filing of a new Notice of Intent.
- 15. The Agent or members of the Conservation Commission and the Department of Environmental Protection shall have the right to enter and inspect the area subject to this Order at reasonable hours to evaluate compliance with the conditions stated in this Order, and may require the submittal of any data deemed necessary by the Conservation Commission or Department for that evaluation.
- 16. This Order of Conditions shall apply to any successor in interest or successor in control of the property subject to this Order and to any contractor or other person performing work conditioned by this Order.

C. General Conditions Under Massachusetts Wetlands Protection Act (cont.)

- 17. Prior to the start of work, and if the project involves work adjacent to a Bordering Vegetated Wetland, the boundary of the wetland in the vicinity of the proposed work area shall be marked by wooden stakes or flagging. Once in place, the wetland boundary markers shall be maintained until a Certificate of Compliance has been issued by the Conservation Commission.
- 18. All sedimentation barriers shall be maintained in good repair until all disturbed areas have been fully stabilized with vegetation or other means. At no time shall sediments be deposited in a wetland or water body. During construction, the applicant or his/her designee shall inspect the erosion controls on a daily basis and shall remove accumulated sediments as needed. The applicant shall immediately control any erosion problems that occur at the site and shall also immediately notify the Conservation Commission, which reserves the right to require additional erosion and/or damage prevention controls it may deem necessary. Sedimentation barriers shall serve as the limit of work unless another limit of work line has been approved by this Order.
- 19. The work associated with this Order (the "Project")

If the work is subject to the Stormwater Standards, then the project is subject to the following conditions:

- a) All work, including site preparation, land disturbance, construction and redevelopment, shall be implemented in accordance with the construction period pollution prevention and erosion and sedimentation control plan and, if applicable, the Stormwater Pollution Prevention Plan required by the National Pollution Discharge Elimination System Construction General Permit as required by Stormwater Condition 8. Construction period erosion, sedimentation and pollution control measures and best management practices (BMPs) shall remain in place until the site is fully stabilized.
- b) No stormwater runoff may be discharged to the post-construction stormwater BMPs unless and until a Registered Professional Engineer provides a Certification that: *i.* all construction period BMPs have been removed or will be removed by a date certain specified in the Certification. For any construction period BMPs intended to be converted to post construction operation for stormwater attenuation, recharge, and/or treatment, the conversion is allowed by the MassDEP Stormwater Handbook BMP specifications and that the BMP has been properly cleaned or prepared for post construction operation, including removal of all construction period sediment trapped in inlet and outlet control structures; *ii.* as-built final construction BMP plans are included, signed and stamped by a Registered Professional Engineer, certifying the site is fully stabilized;

iii. any illicit discharges to the stormwater management system have been removed, as per the requirements of Stormwater Standard 10:

iv. all post-construction stormwater BMPs are installed in accordance with the plans (including all planting plans) approved by the issuing authority, and have been inspected to ensure that they are not damaged and that they are in proper working condition;

- v. any vegetation associated with post-construction BMPs is suitably established to withstand erosion.
- c) The landowner is responsible for BMP maintenance until the issuing authority is notified that another party has legally assumed responsibility for BMP maintenance. Prior to requesting a Certificate of Compliance, or Partial Certificate of Compliance, the responsible party (defined in General Condition 18(e)) shall execute and submit to the issuing authority an Operation and Maintenance Compliance Statement ("O&M Statement) for the Stormwater BMPs identifying the party responsible for implementing the stormwater BMP Operation and Maintenance Plan ("O&M Plan") and certifying the following:
 - i.) the O&M Plan is complete and will be implemented upon receipt of the Certificate of Compliance, and
 - ii.) the future responsible parties shall be notified in writing of their ongoing legal responsibility to operate and maintain the stormwater management BMPs and implement the Stormwater Pollution Prevention Plan.
- d) Post-construction pollution prevention and source control shall be implemented in accordance with the long-term pollution prevention plan section of the approved Stormwater Report and, if applicable, the Stormwater Pollution Prevention Plan required by the National Pollution Discharge Elimination System Multi-Sector General Permit.
- e) Unless and until another party accepts responsibility, the landowner, or owner of any drainage easement, assumes responsibility for maintaining each BMP. To overcome this presumption, the landowner of the property must submit to the issuing authority a legally binding agreement of record, acceptable to the issuing authority, evidencing that another entity has accepted responsibility for maintaining the BMP, and that the proposed responsible party shall be treated as a permittee for purposes of implementing the requirements of Conditions 18(f) through 18(k) with respect to that BMP. Any failure of the proposed responsible party to implement the requirements of Conditions 18(f) through 18(k) with respect to that BMP shall be a violation of the Order of Conditions or Certificate of Compliance. In the case of stormwater BMPs that are serving more than one lot, the legally binding agreement shall also identify the lots that will be serviced by the stormwater BMPs. A plan and easement deed that grants the responsible party access to perform the required operation and maintenance must be submitted along with the legally binding agreement.
- f) The responsible party shall operate and maintain all stormwater BMPs in accordance with the design plans, the O&M Plan, and the requirements of the Massachusetts Stormwater Handbook.

- g) The responsible party shall:
 - 1. Maintain an operation and maintenance log for the last three (3) consecutive calendar years of inspections, repairs, maintenance and/or replacement of the stormwater management system or any part thereof, and disposal (for disposal the log shall indicate the type of material and the disposal location):
 - 2. Make the maintenance log available to MassDEP and the Conservation Commission ("Commission") upon request; and
 - Allow members and agents of the MassDEP and the Commission to enter and
 inspect the site to evaluate and ensure that the responsible party is in compliance
 with the requirements for each BMP established in the O&M Plan approved by the
 issuing authority.
- h) All sediment or other contaminants removed from stormwater BMPs shall be disposed of in accordance with all applicable federal, state, and local laws and regulations.
- i) Illicit discharges to the stormwater management system as defined in 310 CMR 10.04 are prohibited.
- j) The stormwater management system approved in the Order of Conditions shall not be changed without the prior written approval of the issuing authority.
- k) Areas designated as qualifying pervious areas for the purpose of the Low Impact Site Design Credit (as defined in the MassDEP Stormwater Handbook, Volume 3, Chapter 1, Low Impact Development Site Design Credits) shall not be altered without the prior written approval of the issuing authority.
- Access for maintenance, repair, and/or replacement of BMPs shall not be withheld.
 Any fencing constructed around stormwater BMPs shall include access gates and shall be at least six inches above grade to allow for wildlife passage.

F. Appeals

The applicant, the owner, any person aggrieved by this Order, any owner of land abutting the land subject to this Order, or any ten residents of the city or town in which such land is located, are hereby notified of their right to request the appropriate MassDEP Regional Office to issue a Superseding Order of Conditions. The request must be made by certified mail or hand delivery to the Department, with the appropriate filing fee and a completed Request for Departmental Action Fee Transmittal Form, as provided in 310 CMR 10.03(7) within ten business days from the date of issuance of this Order. A copy of the request shall at the same time be sent by certified mail or hand delivery to the Conservation Commission and to the applicant, if he/she is not the appellant.

Any appellants seeking to appeal the Department's Superseding Order associated with this appeal will be required to demonstrate prior participation in the review of this project. Previous participation in the permit proceeding means the submission of written information to the Conservation Commission prior to the close of the public hearing, requesting a Superseding Order, or providing written information to the Department prior to issuance of a Superseding Order.

The request shall state clearly and concisely the objections to the Order which is being appealed and how the Order does not contribute to the protection of the interests identified in the Massachusetts Wetlands Protection Act (M.G.L. c. 131, § 40), and is inconsistent with the wetlands regulations (310 CMR 10.00). To the extent that the Order is based on a municipal ordinance or bylaw, and not on the Massachusetts Wetlands Protection Act or regulations, the Department has no appellate jurisdiction. Appeals of this Order under the West Tisbury Wetlands Protection Bylaw and Regulations may be made to the Dukes County Superior Court in accordance with M.G.L. Ch. 249 Sec.4.

Project Description and Jurisdiction:

On December 11, 2018, Vineyard Land Surveying & Engineering, Inc., filed a Notice of Intent (NOI) on behalf of Blue Heron, LLC (the "Applicant"), for a project at 99 Pond View Farm Road. The project consists of grading within the Buffer Zone in connection with construction activities associated with the construction of a single-family dwelling outside the Buffer Zone as shown on the project plan referenced below.

The Conservation Commission has conducted an on-site inspection, reviewed the NOI and submitted information and has determined that the area where the work is proposed is significant to the values of the Wetlands Protection Act and 310 CMR10.00 (the "Act"), and the West Tisbury Wetlands Protection Bylaw and Regulations (the "Bylaw"). A public hearing was held on January 22, 2019. There was no public comment.

This project was reviewed for compliance with the Act at Section 10.02 (Statement of Jurisdiction) and Section 10.24 General Provisions.

Under Section II of the Bylaw, the Buffer Zone is considered to be a Resource Area. This project was reviewed for compliance with the Bylaw Regulations Sections IV (Buffer Zone) and Section XXI (Estimated Habitats of Rare Species and Wildlife). The Applicant requested a waiver from compliance with the performance standards in Section XXI dealing with alterations within 25 to 50 feet of Estimated Habitat.

Findings:

In making a decision on this project, the Commission has considered the magnitude of alteration, the environmental significance of the site, reasonable alternatives, and the minimization of impact and the extent of mitigation measures.

The Commission finds that each parcel of land and proposed project thereon has its own unique characteristics and impacts, therefore, every project brought before the Commission for approval will be considered on a site specific basis. And, because of this site specificity, each project will stand alone and shall not set a precedent in the decisions to be made on subsequent projects. Due to the project location and project design, the proposed project, as conditioned, is allowed but the approval does not set any sort of precedent as each property and project are determined on their own merits.

The Commission finds that work located in the Buffer Zone to the top of a coastal bank that will alter this area is reviewable by the Commission under 310 CMR 1 0.02 (3) when such activities do not meet the requirements of 310 CMR 10.02 (2)(b) 2.

EXHIBIT A

The Commission finds that that the work will have no significant adverse impact on the resource area if constructed in accordance with the special conditions set forth below.

The Commission finds that there will be no adverse impact to Estimated Habitat and therefore waives compliance with the performance standards at Section XXI. C. 2-5.

The Commission approves the proposed project under the Act and the Bylaw subject to the following special conditions.

Special Conditions under both the Act and the Bylaw

- 1) The Applicant and the Applicant's agent(s) shall adhere to General Conditions 1 through 17 of this Order.
- 2) The term "Applicant" as used in this Order of Conditions shall refer to the owner, any successor in interest or successor in control of the property referenced in the Notice of Intent, supporting documents and this Order of Conditions. The Commission shall be notified in writing within 30 days of all transfers of title of any portion of property that take place prior to issuance of the Certificate of Compliance.
- 3) The form provided at the end of this Order shall be completed and stamped at the Dukes County Registry of Deeds, after the expiration of the 10-day appeal period and if no request of appeal has been filed with the Department of Environmental Protection. This form shall be returned to the Commission in accordance with General Condition 8, and prior to the commencement of work.
- 4) The Commission has approved the proposed project in accordance with the specifications shown a plan entitled, "Site Plan in West Tisbury, Mass", prepared for Blue Heron LLC by Vincyard Land Surveying & Engineering, Inc., dated January 22, 2019 (the "Project Plan"). All notes on the Project Plan are adopted as additional conditions unless otherwise stated. Where the Commission's orders are more restrictive, the Order shall apply. No deviation from the Project Plan is permitted without prior written approval of the Commission. Any change to the Project Plan requires prior approval by the Commission. See General conditions No. 13 and No. 14 regarding approval of changes to the Project Plan.
- 5) It is the responsibility of the Applicant to procure all other applicable federal state and local permits and approvals associated with this project. Should issuance of additional permits result in a change in the project, the provisions of special condition #4 above apply regarding the process for plan changes shall apply.
- 6) It is the responsibility of the Applicant, Applicant's representative, owner and /or successor (s) to ensure that all conditions of this Order are complied with. A copy of this Order of Conditions including the special conditions and Project Plan shall be included in all construction contracts, subcontracts and specifications and

shall be available on-site upon commencement and during the performance of any and all construction activities regulated by this Order.

- 7) All site contractors shall review and adhere to these conditions in performing the approved activities. The Applicant or its representative shall obtain a signed receipt from all site contractors stating that they have reviewed and will adhere to this Order. The receipt(s) shall be submitted to the Commission. Any adverse impact the Buffer Zone caused by vehicles, equipment or workers shall be mitigated immediately by the Applicant in consultation with the Commission.
- 8) Prior to the start of any excavation or construction, the DEP sign and a limit of work line consisting of ridged snow fencing with silt fencing securely stapled and properly installed five (5) feet from the brown shaded area to be graded as shown on the Project Plan and must be in place at the time of the preconstruction site visit. The pre-construction meeting shall be on site involving the contractor conducting the work, the site engineer, the Applicant or their agent, and a member or agent of the Commission to ensure that all parties understand the requirements of this Order and to view the erosion control measures. The pre-construction site visit shall be arranged with the Commission office at least 72 hours in advance of the start of work.
- 9) No construction activities, storage of equipment or materials or stockpiling of excavated fill shall occur on the water side of the limit of work. Any excavated materials (that are not removed off site) and the top soil to be reused, shall be stockpiled outside the Buffer Zone and stabilized as necessary.
- 10) Site grading and construction shall be scheduled to avoid periods of high surface waters. Once begun, grading and construction shall continue in an expeditious manner to minimize the opportunity for erosion.
- 11) The project site shall be cleaned at the each work day and a dumpster placed outside the Buffer Zone. All windblown debris shall be collected and not allowed to enter the pond.
- 12) There shall be no activity within the Buffer Zone except within the brown shaded area on the Project Plan.
- 13) The three Eastern Red Cedars within the boundary of Estimate Habitat shown on the Project Plan shall not be removed. This is an ongoing condition that does not expire with the issuance of a Certificate of Compliance.
- 14) Transplanting of several Eastern Red Cedars within the No-Build Zone (second 25 feet of the Buffer Zone) has been approved under Order of Conditions SE79-389. Note that the removal of the 40-50 Eastern Red Cedar Trees within the No-Disturbance Zone (first 25 feet of the Buffer Zone) was not approved under SE79-389.

- 15) Any landscaping beyond the grading, top dressing and seeding the of the Outer Buffer Zone requires the submittal of a landscaping plan for review and written approval of this board and may requirement an amendment to this Order if additional conditions are required. This is an ongoing condition that does not expire with the issuance of a Certificate of Compliance.
- 16) No chemical fertilizers, herbicides, pesticides or fungicides shall be used in the Buffer Zone. The Applicant shall abide by the West Tisbury Board of Health Regulations for the application of fertilizers. This is an ongoing condition that does not expire with the issuance of a Certificate of Compliance.
- 17) A Completed Request for a Certificate of Compliance form:
 - 1. An as-built survey signed and stamped by a RPE or Land Surveyor, shall be submitted to the Commission upon completion of the project. A statement of any deviations from the Project Plan is required.
 - 2. A set of post-construction photographs of the work areas, access and project locus immediately after completion.
- 18) In case of emergencies, problems or the need to discuss site conditions with the Commission, call the Board Administrator at 508-696-6404.
