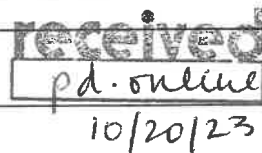

Installation of a 16'x40' fiberglass in-ground swimming pool.

Below is a list of the pool equipment that we plan to use for our pool at 100 Pond Road:

- Pentair MasterTemp 400K BTU propane heater
- Pentair IntelliFlo variable speed pump
- Pentair Intellicenter controls
- Pentair Salt chlorinator
- Pentair LED MicroBrite lights (4)-
underwater lights
- Jandy 580 SF cartridge filter

The pool equipment will be housed inside a small 6x10' shed with a concrete floor. I have included a picture for your record.



The decking surrounding the pool will be concrete pavers. The final design is to be determined but it will be as simple as possible.

The fence will be a four-foot post and beam fence with black chicken wire as per the photo below.
