Dear Joe,

Following up on my email below, I am attaching two pictures I took on November 11 of Mr. Oliveira's multiple vehicles on site.

My Lumix Camera puts the date in the picture file name. The time may be off by an hour, as I had not changed the camera to daylight savings time.

I believe this activity, which has been ongoing is a violation of the Special Permit 2017-07 granted in 2017. In particular, Finding 7: "There will not be an increase in traffic at the property due to business activities. No product deliveries for the business will be made to the property."

As to Finding 8: "The barn is for storage of equipment only. No storage of product is allowed with the exception of the small amount of product remaining in the hoses and trailer."

Mr. Oliveira claims that he build the barn in such a way that he cannot store his trucks inside. How is this storage of equipment and the moving and delivery of product on site outside of the barn consistent with the Special Permit?

I previously sent you pictures of deliveries last July and August to Luis Oliveira's barn/garage at 560 State Road that appear to be in violation of his Special Permit.

Thank you for your email of October 6 to the Zoning Board of Appeals concerning the violation of storing material in the barn/garage per Special Permit 2017-07.

The email I am forwarding from Patricia Linn is of pictures taken the same day, October 6, of deliveries of barrels to the property or removal of them and/or storage in the silver storage container/box trailer.

What is the storage container/box trailer on site that is used to hold these barrels? Is it permitted under zoning?

What are the barrels, what do they contain, and are they permitted on site? This activity appears to be in violation of the Special Permit.

Has removal of the insulation stored in the barn/garage been completed?

Thank you for your attention to this matter.

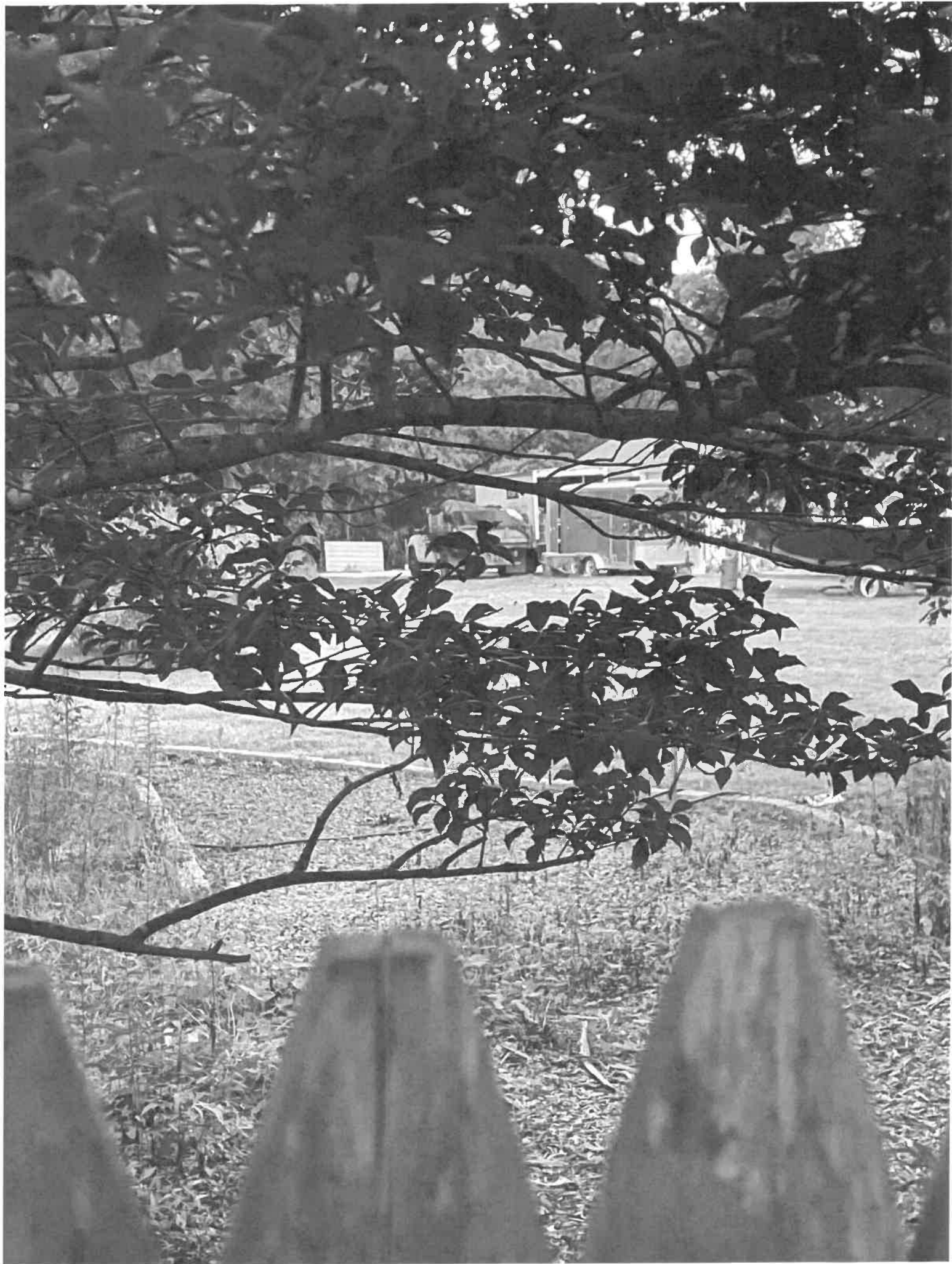
