Project Scope: Swimming Pool & Equipment Shed

Location: 11 Music St, West Tisbury, MA

Dear Board Members,

We respectfully request a hearing for special permit approval of an in-ground swimming pool (8.5-4) and setback relief for a 120 sq.ft. equipment shed (4.2-2) which we propose for our home at 11 Music Street, West Tisbury, MA. Grace's mother will be residing with us and has a disability which is greatly helped by aquatic exercises. The area which we propose locating the swimming pool is currently screened from the public way by an existing 6' fence. The pool equipment is proposed to be located in a soundproof enclosure which would also house the equipment for our advanced septic blower.

Particulars of our design are as follows and indicated on the attached site plan:

- Fencing will be existing stockade facing the street and plastic coated metal mesh when concealed within the landscaping, compliant with CMR 780-421.
- All gates though pool fencing will be self closing and latching, compliant with CMR 780-421.
- An automatic pool cover will be installed by the pool contractor.
- The proposed pool location meets all setbacks.
