Per discussions with Pam Thors at the ZBA, I wanted to clearly layout the changes we are requesting to the Host Community Agreement and Special Permits.

Host Community Agreements

1. As noted in the letter written, the **only** proposed change to the HCA is the changing of the ownership from PCMV to FFD Enterprises MA, Inc and our individuals in that entity.

Special Permit

In the Special Permit, we are requesting FOURminor amendments:

- 1. The Change of the Applicant/Owner of the Special Permit from PCMV to FFD Enterprises MA, Inc
- 2. The addition of Mike Boyle, FFD's Security and Compliance Director
 - 1. Mike had a 28 year career in the DEA. After his retirement, Mike became an inspector for the CCC's medical marijuana program for two years. FFD hired Mike directly from the CCC
- 3. Interior design changes to the dispensary at 510 State Road
- 4. The exterior sign at the dispensary will switch from PCMV's logo to FFD's logo. The signage size will stay exactly the same.
