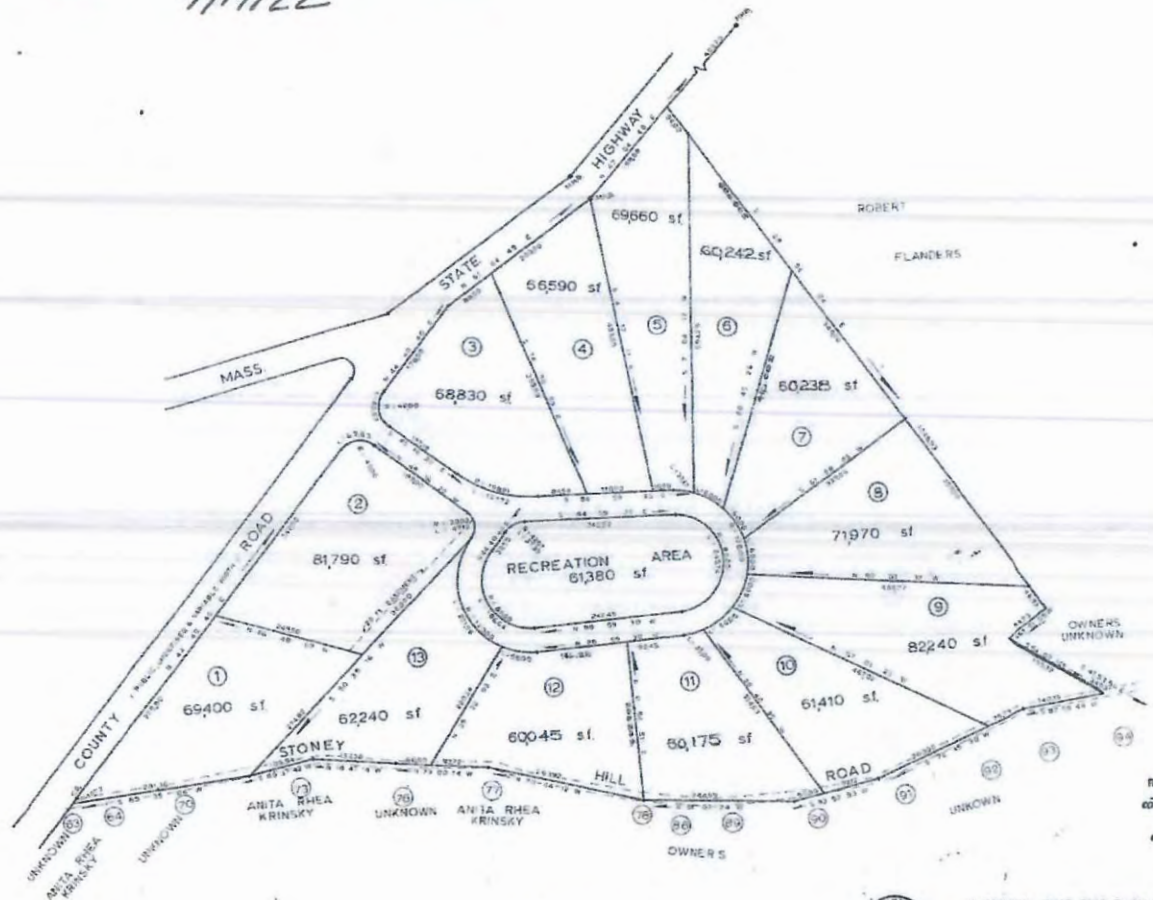

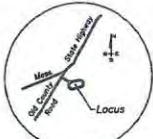
REVISED SUBDIVISION

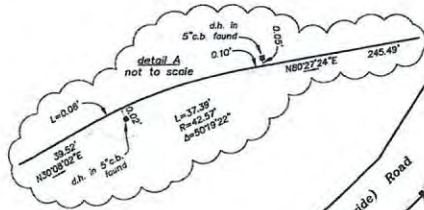
