Today a few neighbors had contacted Mr. Murphy and told him kids were playing there, he was concerned and didn't know how to proceed. I responded to the school and spoke with Laura Marashlian who stated she was under the impression playing on that lot was ok, but now knowing it is not she confirmed with me it will not happen again. I called Mr. Murphy back with my findings who was satisfied by the results and would notify us in the future if this were to occur again.</p>

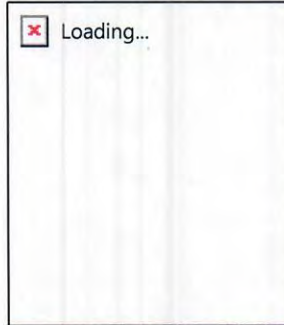
