Hi, I am reaching out per the request of the Building Department. Joe has been consulting us on how to build more farm employee housing. Our idea we wish to create a plan from if it fits the towns rules is as follows.

M31 Lot 68 Simon & Robyn Athearn

Our land bank deed restriction has a farm building zone, that includes staff housing, we had our preliminary plan pass though them at their last board meeting, we will need to return to the Land Bank with a final plan.

Plan: a 2,100 Sf barn with loft for the farm's use. That includes a shared kitchen and bathrooms in a portion of the first floor to service several small detached bedrooms nearby. The detached bedrooms would have electric, wifi, and modest insulation (summer use only expected) but no bathroom, sinks, or kitchens. The expectation of the build is to set the buildings on columns and not dig a true foundation, per the suggestion of Kevin Cusack at Autumn construction, who we wish to be our contractor on this. The number of detached bedrooms would be set by our septic allowances.

Joe at the Building Department sees this as an allowable method to house people where we would not have to mix residential and commercial spaces, thus saving on the near impossible to build (no town water) fire sprinkler system. He asked that we run it by this board before we draw actual plans.

Further our staff have been clearly communicating that they would prefer separate small cottages over the dorm style buildings we have two of in edgartown.

What further plans or things would you need from us to get on the agenda? Or any other suggestions.
