Introduction: Board members and guests were welcomed to the 2020 Annual Meeting by Board President, Steve Nierenberg. He thanked MVPCS faculty and staff for their hard work throughout the year. Most notably throughout the Covid-19 pandemic.

2019 Annual Meeting minutes were approved by the board.

Financial Report: Board Treasurer, Tim McHugh gave an update on the current financial situation and the proposed 2020-21 budget to the board, which was approved. Felicia Cheney was also acknowledged for all her hard work over the past years.

Director's Report: Peter Steedman, Director of MVPCS gave a report on some of the amazing events that occured this academic year. He highlighted the numerous multi-age experiences that

took place, which included the International Peace Day Soccer Game, a whole school Black History Month activity & PTO Family Game Nights. Pete also detailed the numerous project based learning activities that happened within the classroom, during Project Period, class field trips & student internships. He then gave an update on the class of 2020's future plans and outlined his plan to create a focus group centered around an anti-racist and pro-liberation strategy, which will heavily influence the school's curriculum. Finally, Pete talked about notable events coming up in the academic year 2020-2021. This included the 5 Year Charter Renewal, a visit from the IB, a tiered focused monitoring visit that will look at student services and the 25th Anniversary.

Options in Education Report: Peter Steedman gave an OIE report, which included a finance update. The expected net cash flow for 2020 is approximately 35K, with the current cash on hand at 190K. These two figures include 40K in loan forgiveness. The annual appeal raised 8K for 2019 and OIE financed multiple projects throughout the school. These projects included: updating the septic system, new flooring and a 15K grant to upgrade the school's playground equipment.

Parent Teacher Organization (PTO) Report: Peter Steedman gave an update on the PTO from President, Jennifer Knight. Some of the projects the PTO undertook this year included: teacher appreciation days, a professional video for high school graduates and 8th grade graduation gifts. They also funded an effort to provide masks and gloves to families in need during the COVID-19 crisis, and they are currently funding an anti-racist parent/caregiver lending library. Although the Spring Fling was cancelled this year due to COVID-19, the PTO is still in sound financial shape. They are currently creating a survey that will be sent out to the Charter School community to gauge how best to move forward after these last few months.
