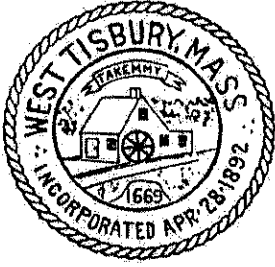

Thank you for your letter requesting joint meetings for planning purposes. The board discussed your letter at our meeting on March 22, 2021 and we are in favor of your request.

We have found that often times applications are presented to our board absent the details other permitting boards will review. This has caused some concern because the plan tends to morph into something beyond either what had been presented, or what the board had anticipated to be appropriate for the site. Reviewing a plan or application as a group could eliminate a lot of missed opportunities and unanswered questions for the benefit of a property.
