## Martha's Vineyard Regional School District SCHOOL COMMITTEE VOTE

VOTED: That the Martha's Vineyard Regional School District hereby appropriates the amount of Two Million (\$2,000,000) Dollars for the purpose of paying costs of a feasibility study relating to the possible replacement or reconstruction of the District High School, located at 100 Edgartown-Vineyard Haven Road, in Oak Bluffs, Massachusetts, including all costs incidental and related thereto (the "Study") said amount to be expended under the direction of the School Building Committee. To meet this appropriation the District is authorized to borrow said amount under and pursuant to G.L. c. 71, §16(d), and the District Agreement, as amended, or pursuant to any other enabling authority. The District acknowledges that the Massachusetts School Building Authority's ("MSBA's") grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the District incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the District; provided further, that the amount of borrowing authorized pursuant to this vote shall be reduced by any grant amount set forth in the Feasibility Study Agreement that may be executed between the District and the MSBA.

FURTHER VOTED: That within seven (7) days from the date on which the above vote was adopted, the Secretary be and hereby is instructed to notify the Board of Selectmen or Select Board, as the case may be, of each of the member towns of the District as to the amount and general purposes of the debt herein authorized, as required by the District Agreement and by G.L. c. 71, §16(d).
