Open Session Meeting Minutes

Board of Assessors, March 29, 2022

1) Minutes March 15, 2022

The Board voted 3-0 to approve the minutes: Colaneri-yes, McFarland-yes, Cohen-yes

2) Abutters List

The Board voted 3-0 to approve the abutters list: Colaneri-yes, McFarland-yes, Cohen-yes

3) Motor Vehicle Excise 2022-2 \$106,158.58
