OLD/NEW BUSINESS:

<u>Discuss/Select Representative to the Landbank</u>- The Board discussed possible applicants to fill the town representative position to the Landbank. The Board wanted to know more information about the responsibilities of the job and the Health Agent said he would get a job description for them. Jess Miller suggested three applicants for the position which included David Bouck, Angela Lucky and Kate Hubbel.

<u>Livestock Burial Regulation Follow-up Discussion:</u> The Board was informed that the Town Administrator, Jen Rand, has granted the Town of West Tisbury's legal counsel for the evaluation of the livestock burial regulation. Legal counsel will review the University of Massachusetts-Amherst livestock burial best practices and determine if the laws can legally be enforced in the Town of West Tisbury.

<u>Discuss Regulation for Enhanced Septic Systems in Proximity to Coastal Ponds-</u> The Board followed up on the discussion to increase septic system regulations in areas in close proximity to coastal ponds. The Health Agent provided septic system by-laws for the towns of Oak Bluffs and Chilmark, which he plans to apply for the Town of West Tisbury. The new regulations will be researched and presented to the Board of Health at the next meeting.

<u>Covid-19 Update:</u> Summarized the number of COVID-19 cases on the island. In the past two weeks, there have been 17 new cases. On Friday November 5, 2021, the Martha's Vineyard Boards of Health voted to keep the mask mandates in place till January 15, 2022. They concluded it would be safer to keep the mask mandate in place till after the holiday season.
