<u>Discuss Regulation for Enhanced Septic Systems in Proximity to Coastal Ponds-</u> The Board followed up on the discussion to increase septic system regulations in areas in close proximity to coastal ponds. The Health Agent provided septic system by-laws for the towns of West Tisbury, Oak Bluffs and Chilmark to Board Member Eric Lowe. The Health Agent reached out to expert George Heufelder for guidance and information on enhanced septic systems.

<u>Covid-19 Update:</u> Summarized the increase in the number of COVID-19 cases on the island. In the past two weeks, there have been 37 new cases. The mobile vaccination bus returned to the Island on November 20 and 21. 84 school children and personnel were vaccinated in the two day period.
