OLD/NEW: Met with Mr. Paul Garcia of 1047 State Road, the home adjacent to the West Tisbury Congregational church. Mr. Garcia requested a meeting to address septic concerns related to the church's expanded use of their kitchen facilities. BOH Chair person Tim Barnett questioned whether the church needed/utilized a grease trap and has recommended water testing. It was agreed that Health Agent Johnson

would look into whether the church may need to make changes/additions to its' kitchen and septic system to accommodate the current use in accordance with Title 5. Paul Mahoney's septic plan was not approved as the Board believed changes could be made to the plan to better meet required separations. Tim Barnett suggested moving the leaching field to the reserve area and the reserve area closer to the parking lot. This suggestion will be passed on to the engineer and the application will be re-reviewed at such time. William Seabourne's septic application was not approved because separations were not clearly indicated on the plot plan. The engineer is being contacted to provide the missing information in order for the application to re-reviewed.
