OLD/NEW BUSINESS:

De-Nitrification Regulations: Shared with the Board members recent notification (June 1st, 2022) from DEP informing all municipalities of regulatory revisions that will require timely action to restore and protect coastal estuaries from excessive nitrogen pollution. There will be two regulatory approaches that will be made available for public comment in the fall. Municipalities will be given a chance to select which approach will be taken to address the concerns. Septic systems (Title V), waste water treatment plants, agriculture, lawns and storm water runoff have been identified as causes. The Health Agent will need to consult with DEP regarding whether current de-nitrification regulations being drafted will be in line and in compliance with State requirements.
