<u>Covid-19 Update</u>: Discussed the decrease of COVID-19 cases on the island. In the past two weeks, there have been 121 new cases. There has been a large decrease in the number of tourists on island.

<u>Septic System Loan Policy:</u> A septic system loan procedure for West Tisbury citizens was approved by the Board. Previously, no protocol was in place. The draft policy will now be submitted to the West Tisbury Board of Selectmen for approval.

Susan Carr (Septic system/trailer permit inquiry): Ms. Carr attended the meeting to get her septic system and trailer permits approved. Her septic system was previously reviewed on a January 14, 2021 Board of Health meeting and was denied approval. The application requested to add a bedroom to an existing 3 bedroom septic system. The Board reached out to her engineer, Vineyard Land Surveying & Engineering, to see if it was possible to purchase an enhanced septic system due to the inadequate size of her lot (.507 acres). No reply was given to the request. The trailer permit submitted to the Board received tentative approval with no habitation allowed until the septic system is approved. The trailer would act as temporary housing during construction on the primary residence.
