•Site Plan Review application from Sheriff's Meadow Foundation to place a 4 lot parking area on the property located at Assessor's Map 12, Lot 14.1, 367 Indian Hill Road:

Ginny said she took a look at the area in question and didn't see any obvious infractions of the special ways zoning bylaw.
