## The board meeting was conducted remotely via Zoom due to the Covid 19 pandemic.

#### **DISCUSSION:**

## •Email from Dan Larkosh RE: Dr. Fisher Road rental units:

Ginny explained that the board now has two copies of leases to rent the Larkosh space in the Light Industrial District, one for Brian Packish and one for the lot formally rented by Carter Hakala. She said the lot containing some equipment and materials has not been reviewed by the board. Bea asked if there is a lesson to be learned regarding future granting of use permits by the board. Ginny said the situation currently rests with the Building Inspector and Mr. Larkosh. Bea asked if Joe reviewes leases for the rentals. Bea suggested the board require conditions in the rental lease. Ginny said Mr. Larcosh has appeared before the board in the past and has been acceptable of the required conditions from the board. However, it doesn't appear to hold. Ginny said the entire property needs to be fenced in and Jane stated that it was her understanding that Joe had made that a requirement. She said she would confirm that with him. Henry suggested the board leave the enforcement to Joe.

#### •MVC Workshops RE: Responsibilities of the Planning Board and Writing Zoning Amendments:

She pointed out that the board is doing what is required in the zoning bylaws regarding Site Plan Review and the rule to not hold a public hearing, as Jane had suggested in the past.
