### Discussion of Funding Formula for the three towns

Chief Retmier and Allison prepared four different funding formulas. Committee Chair Warren Doty shared that various funding possibilities are being looked at that would take into account the uneven number of runs in the three towns. West Tisbury had 55% of runs this past year, 10 % in Aquinnah and Chilmark at 35%.

Committee Chair Warren Doty shared that if the formula was done on raw number of runs, the change would be extraordinary. He continued and stated that the Committee is not prepared to make a recommendation today but he is looking at

the numbers. Committee Chair Jim Newman and attendee Allen Rugg thanks the committee for looking at this.
